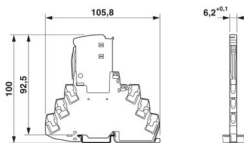

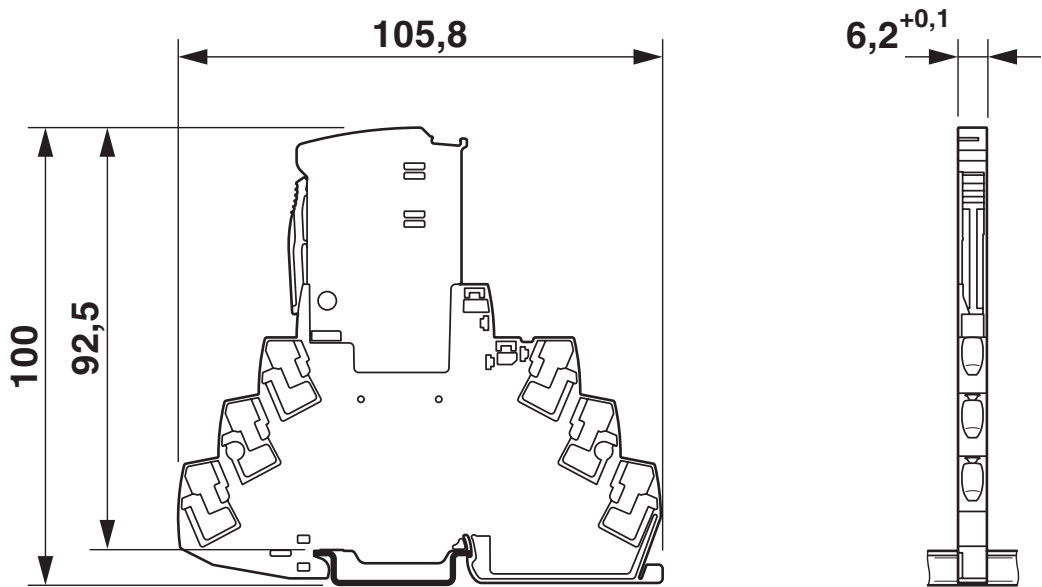

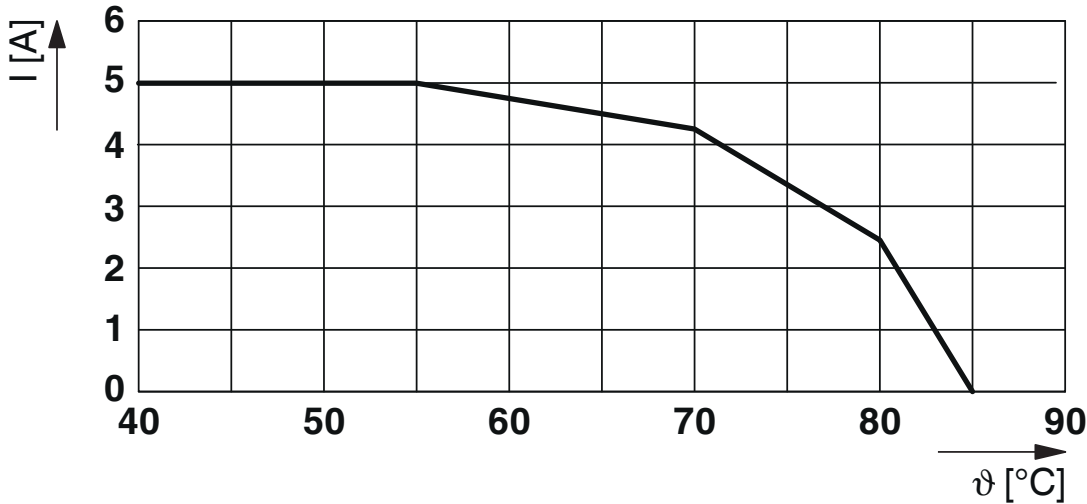


Schematic diagram

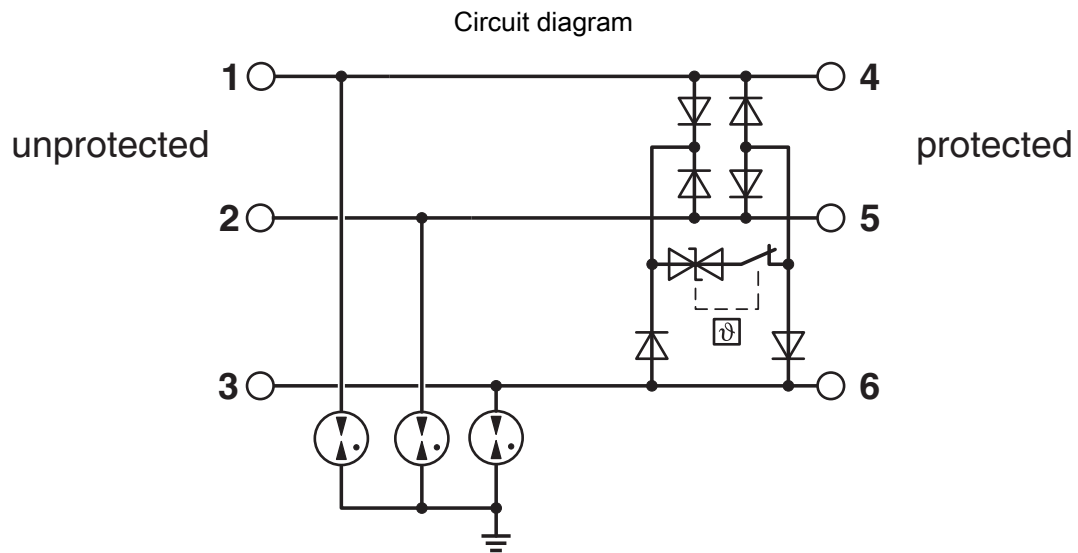


Derating for non-potentially explosive areas and potentially explosive areas (zone 2, EX ec)
