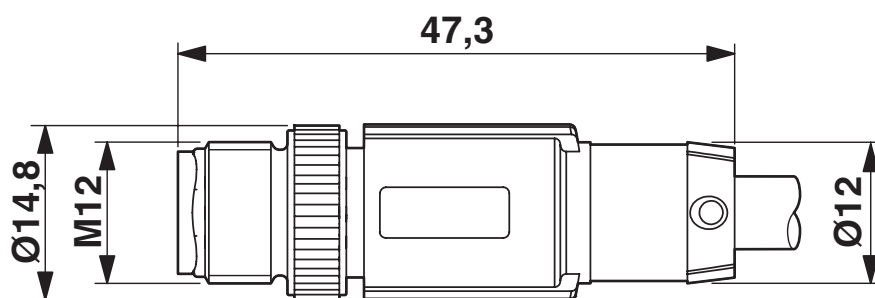

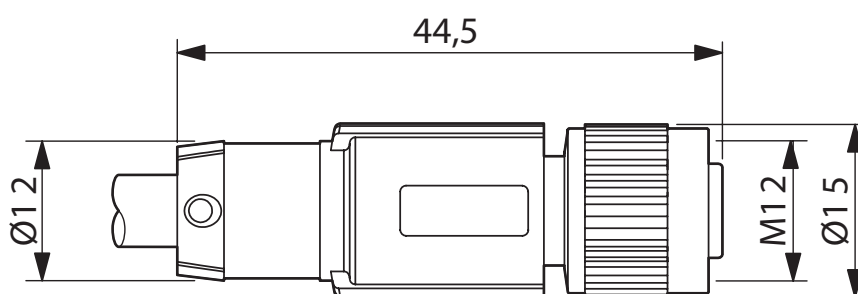

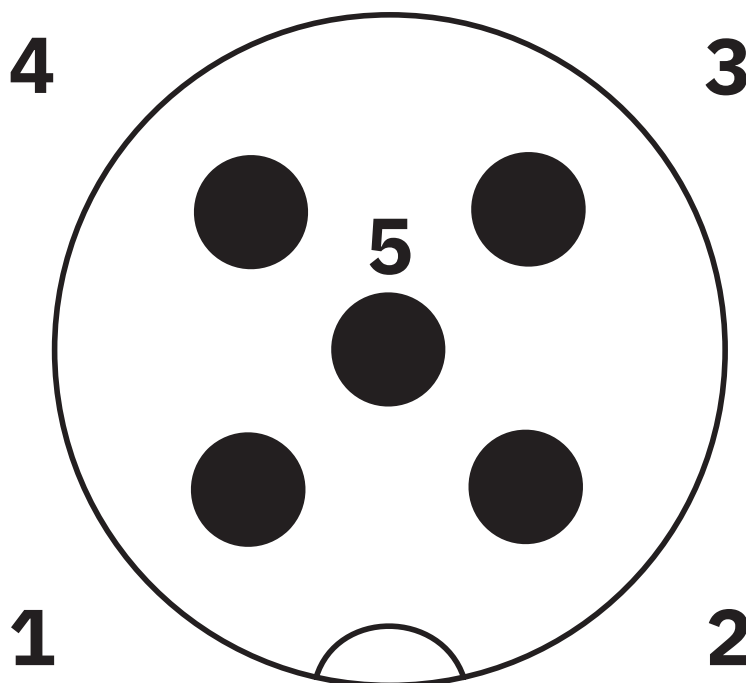
Plug, M12 x 1, straight, shielded

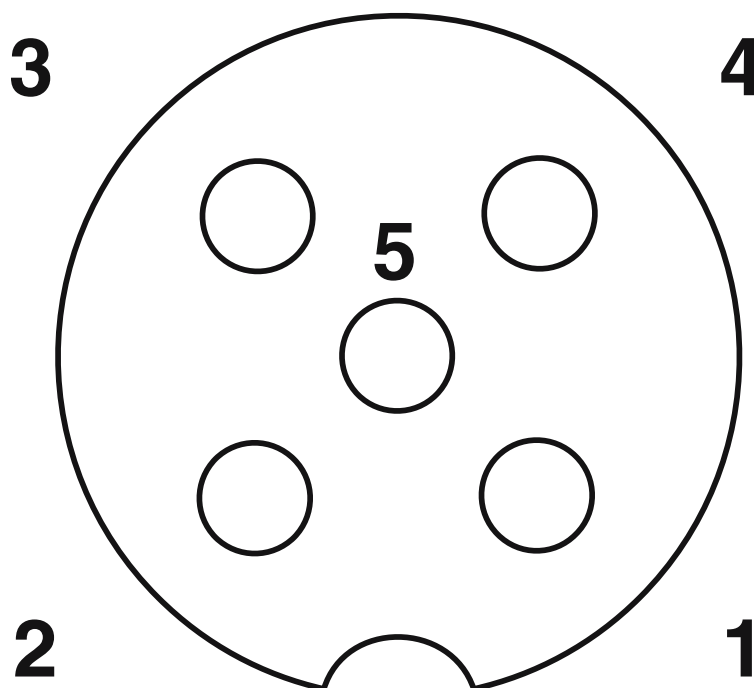
M12 x 1 socket, straight

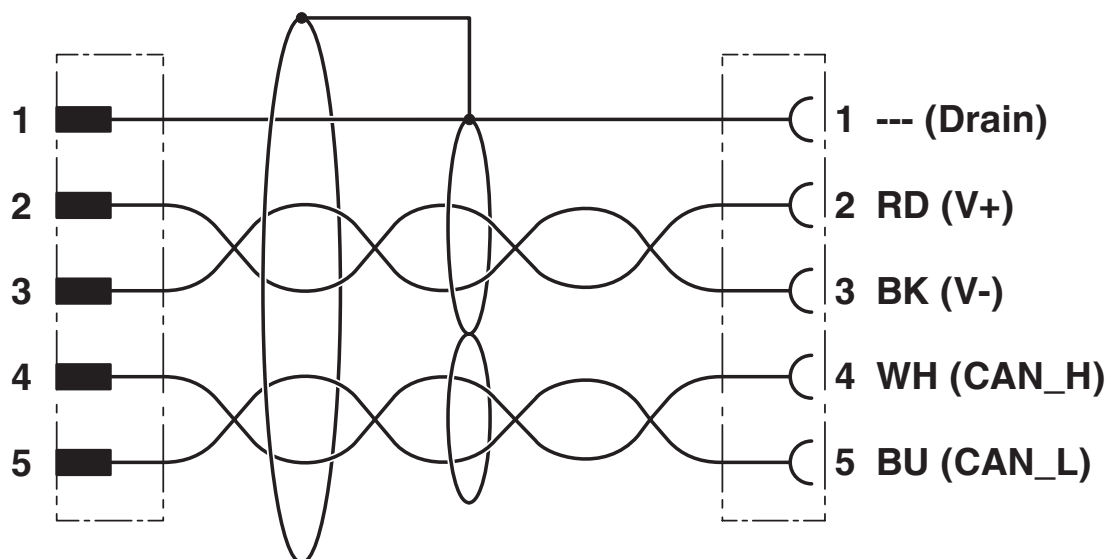


Pin assignment M12 socket, 5-pos., A-coded, socket side view
