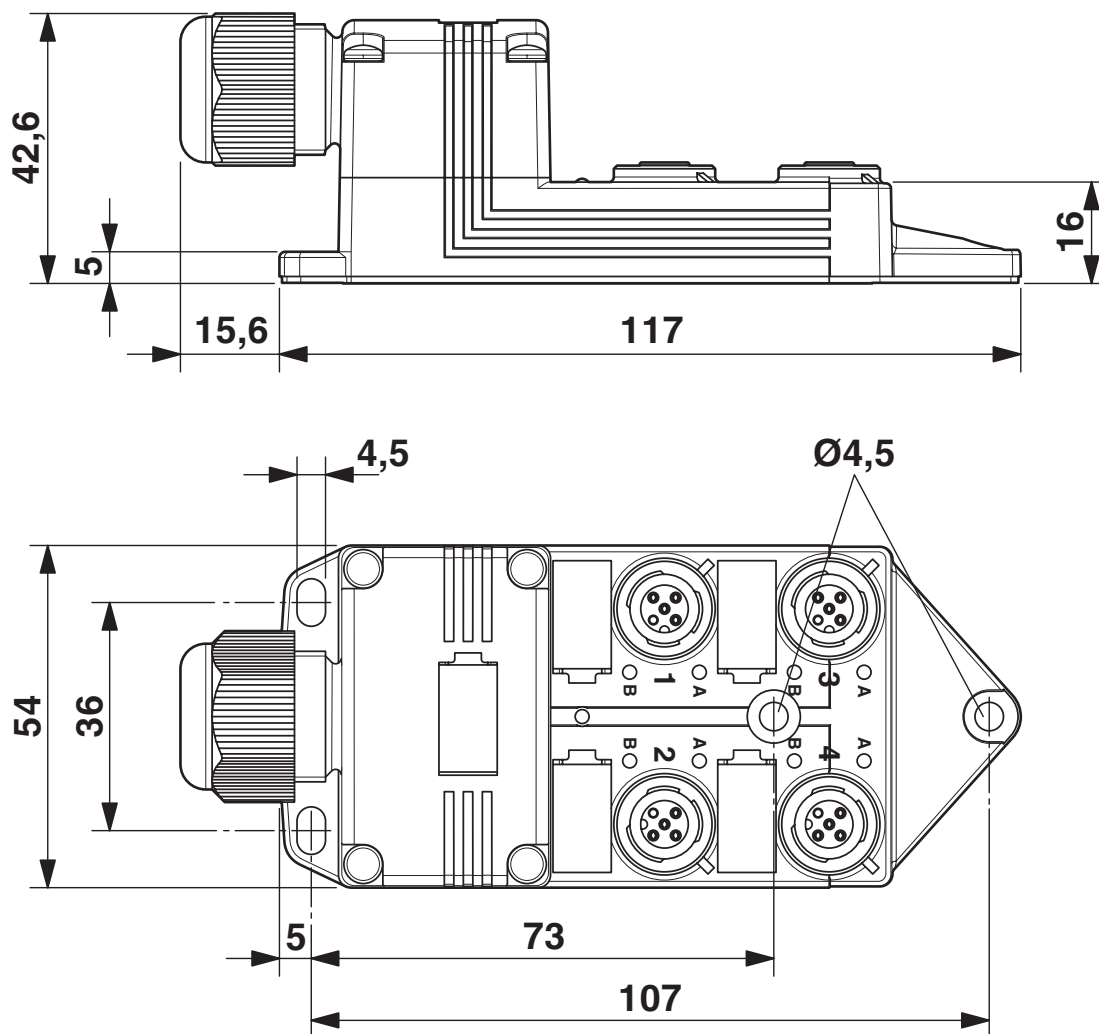

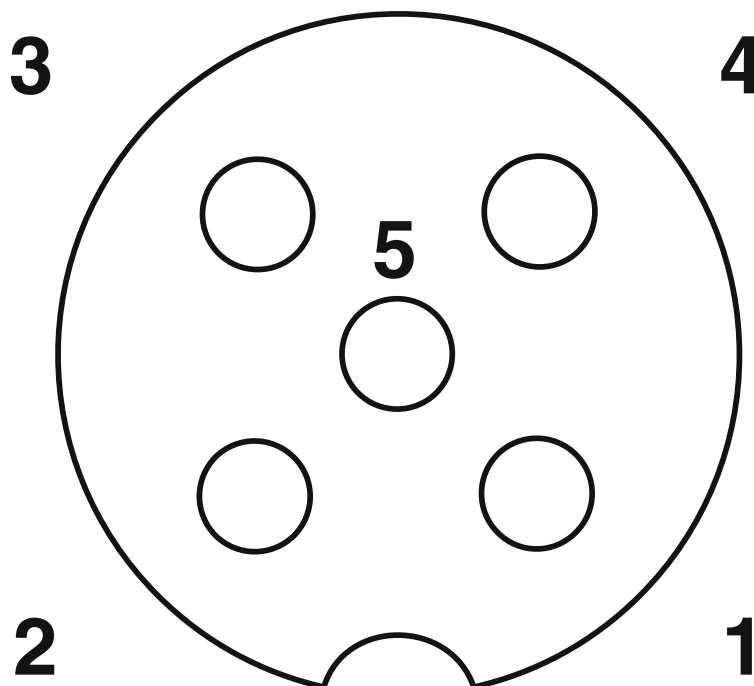

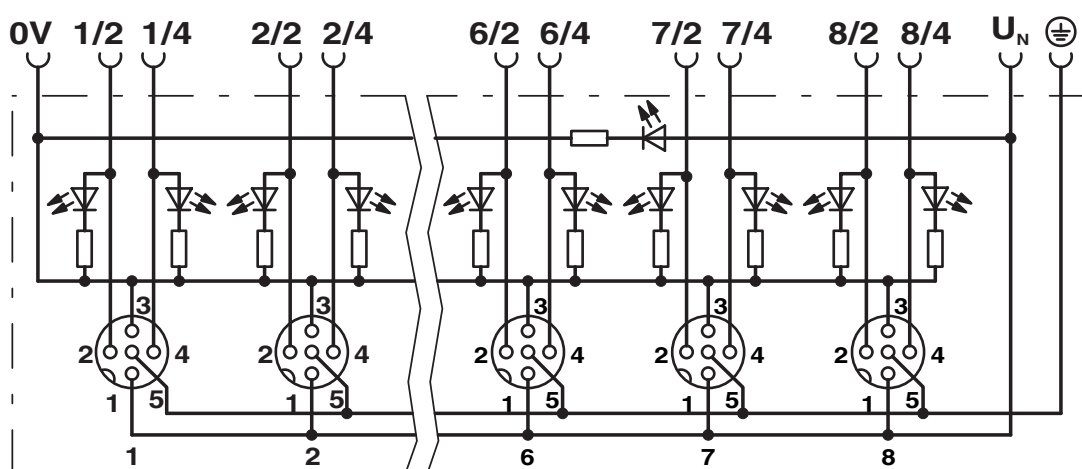


Schematic diagram
