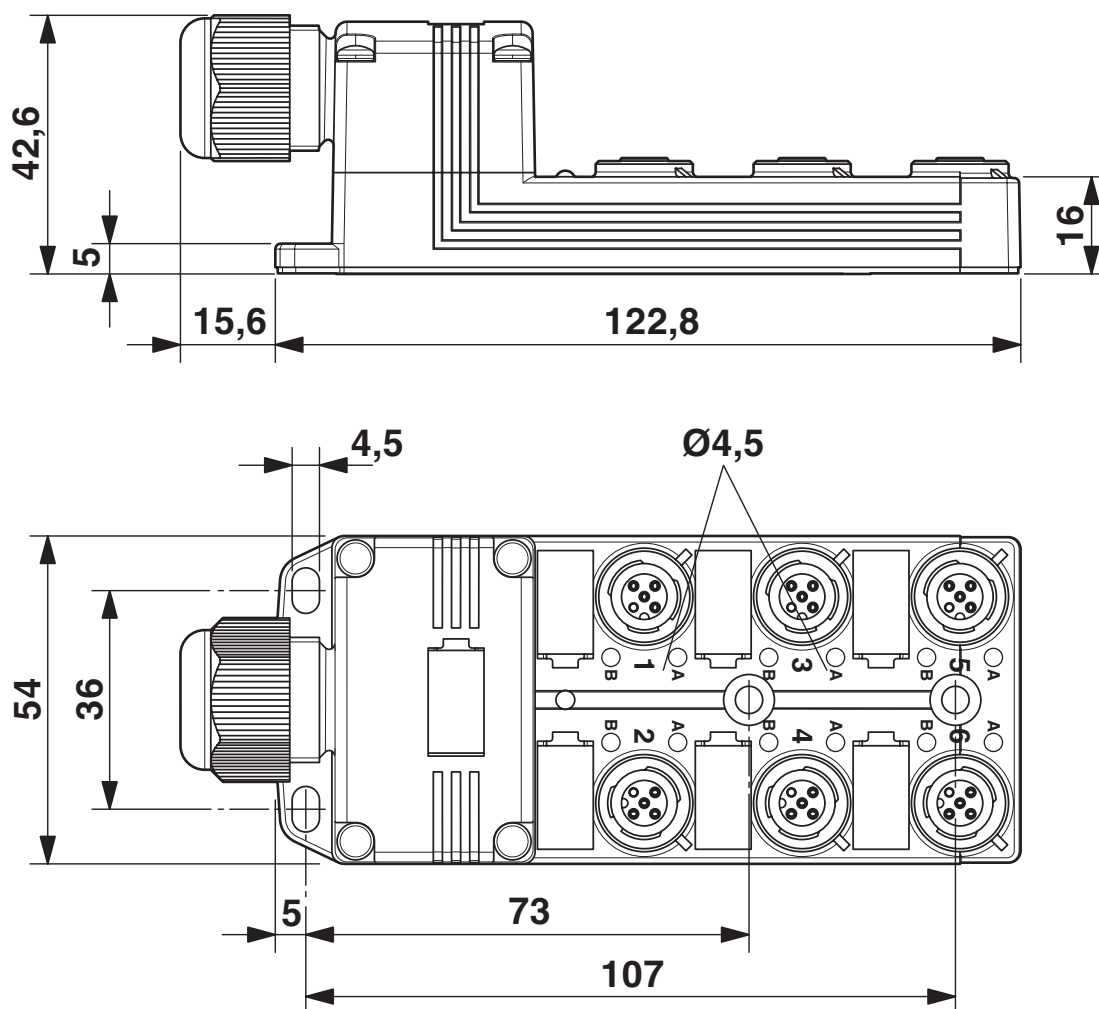

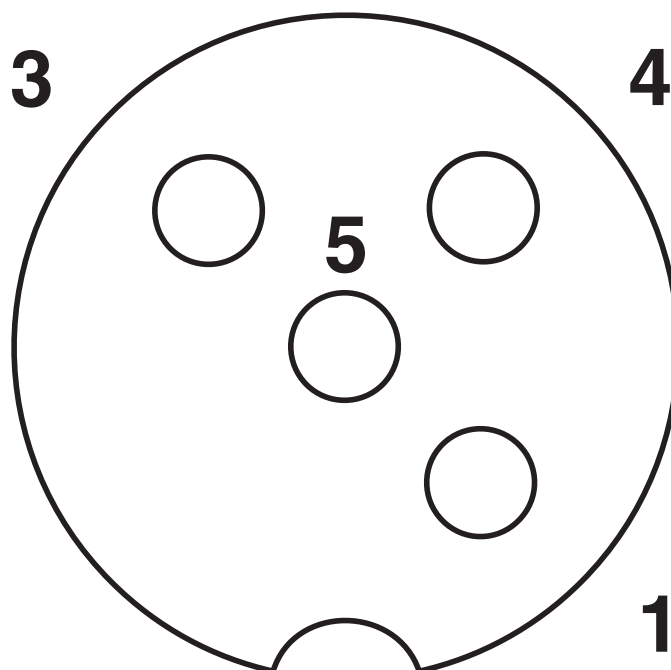

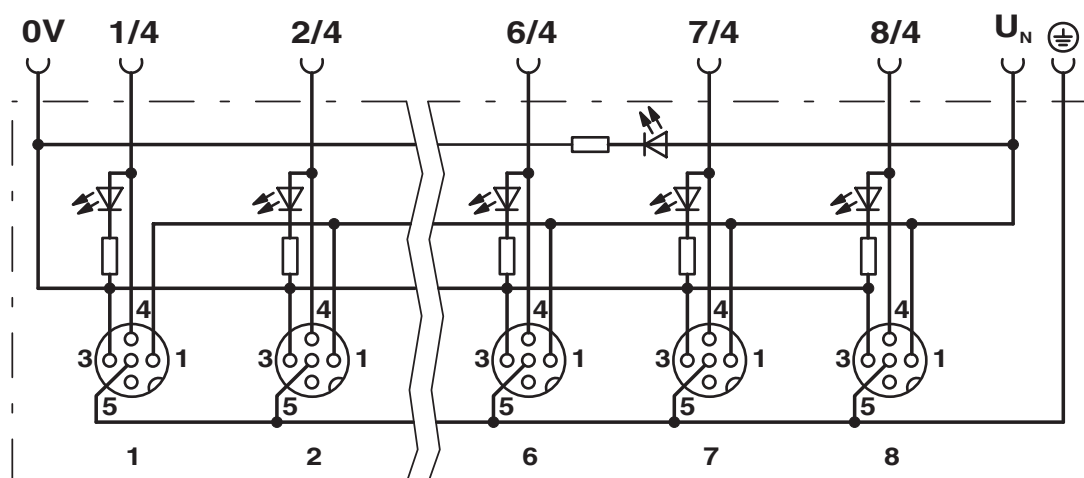


Schematic diagram
