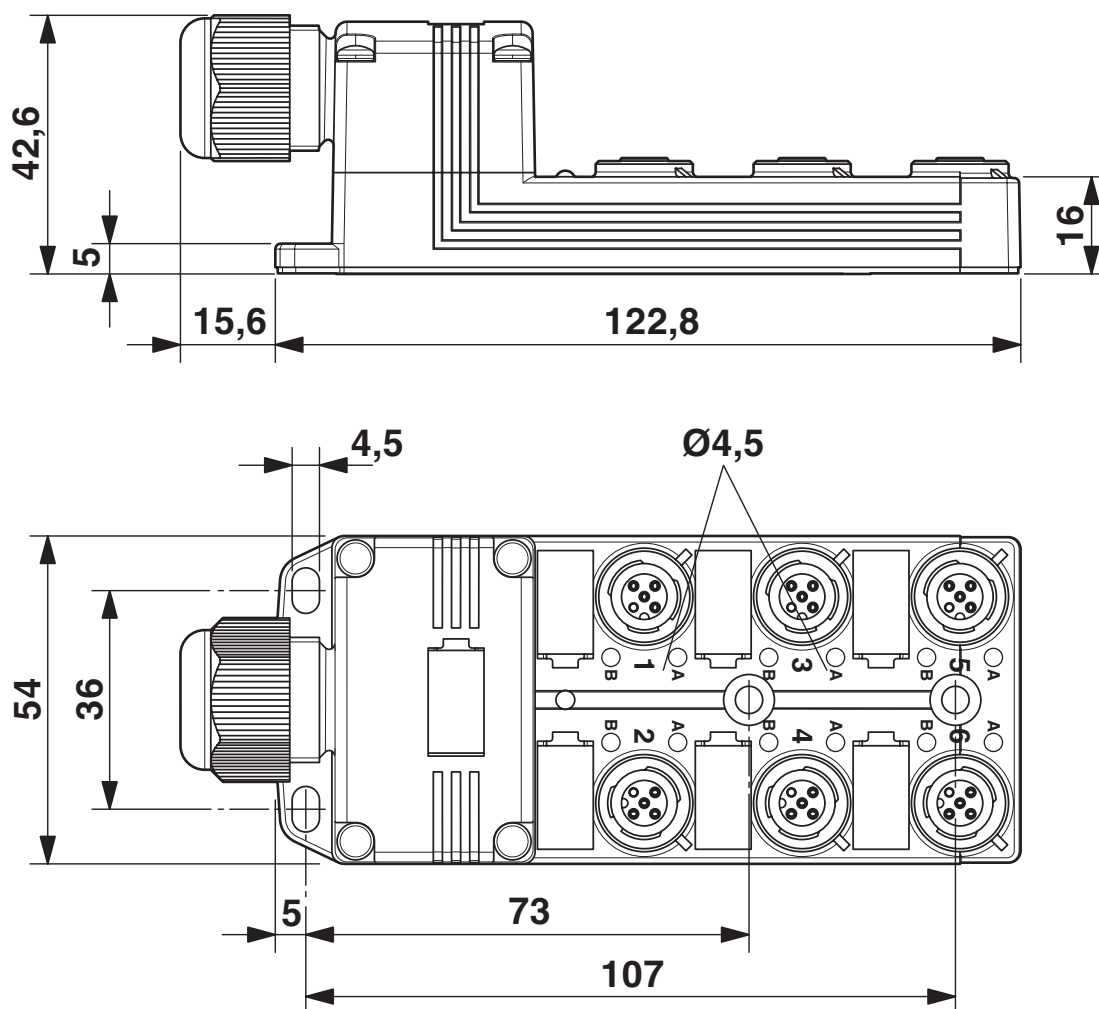

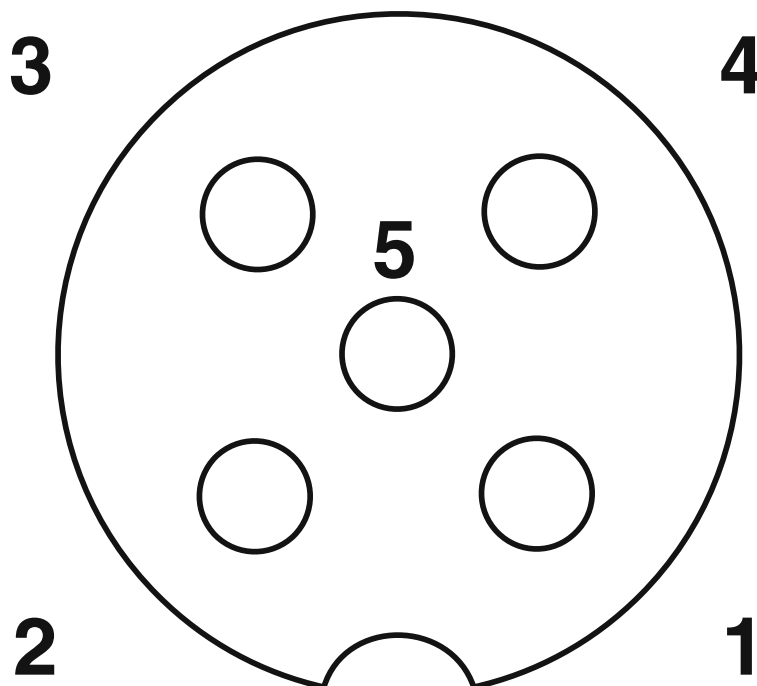

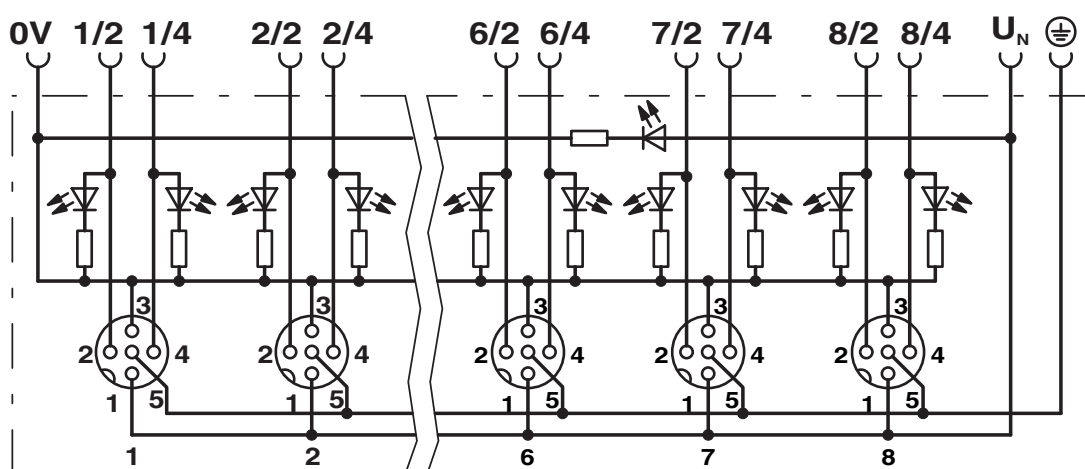


Schematic diagram
