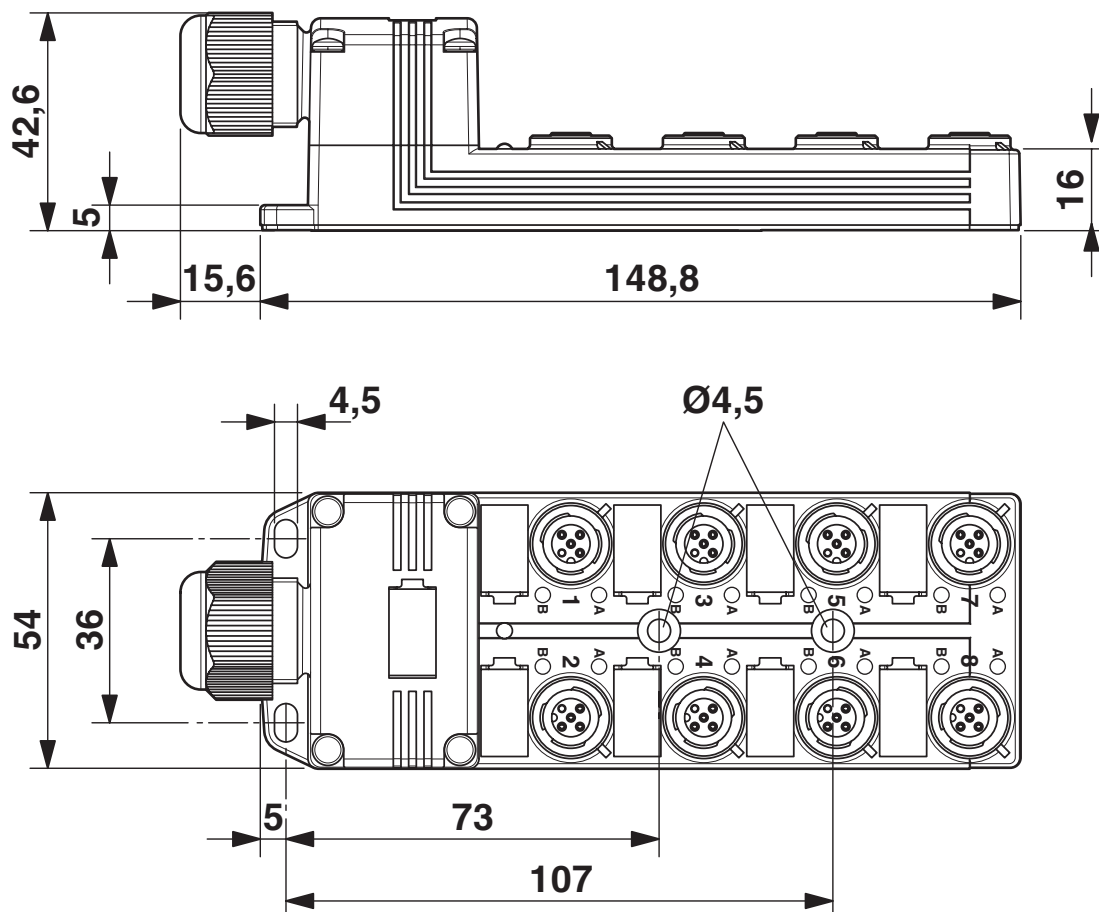

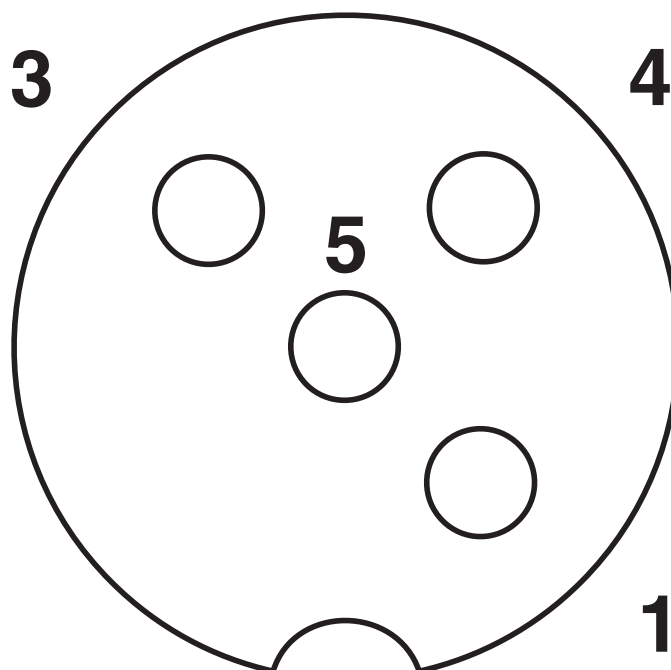

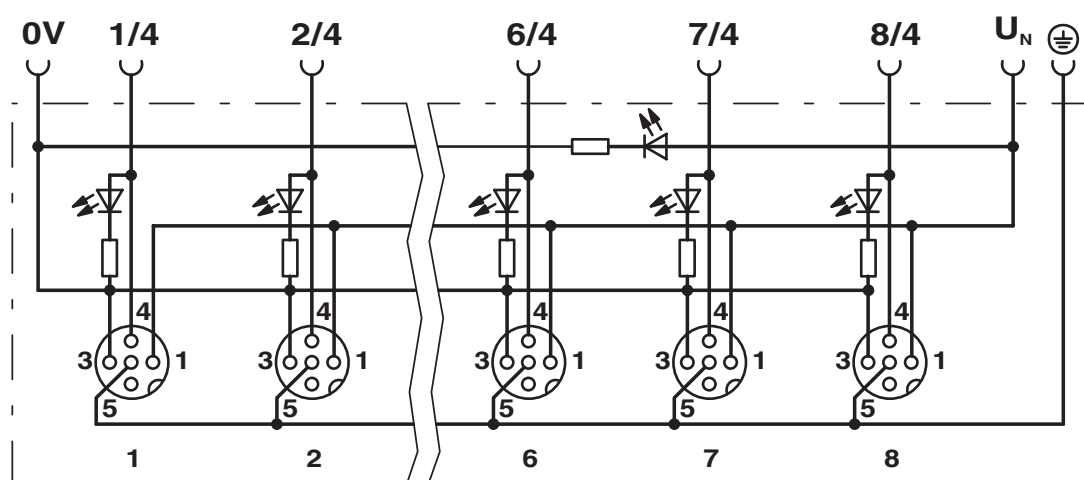


Schematic diagram
