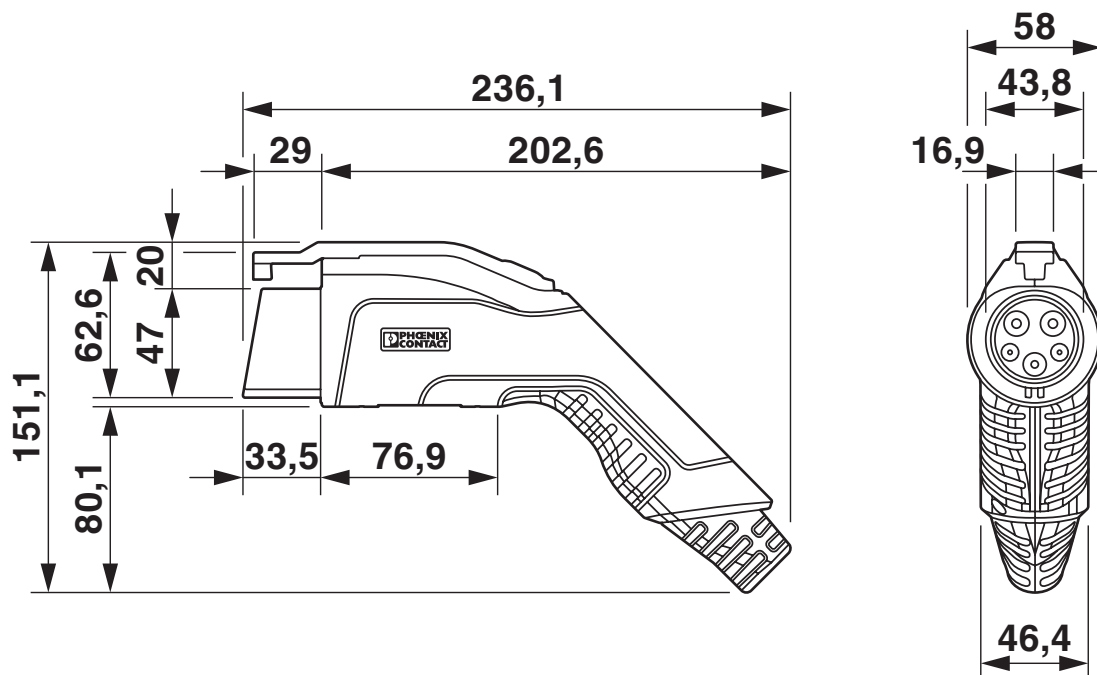

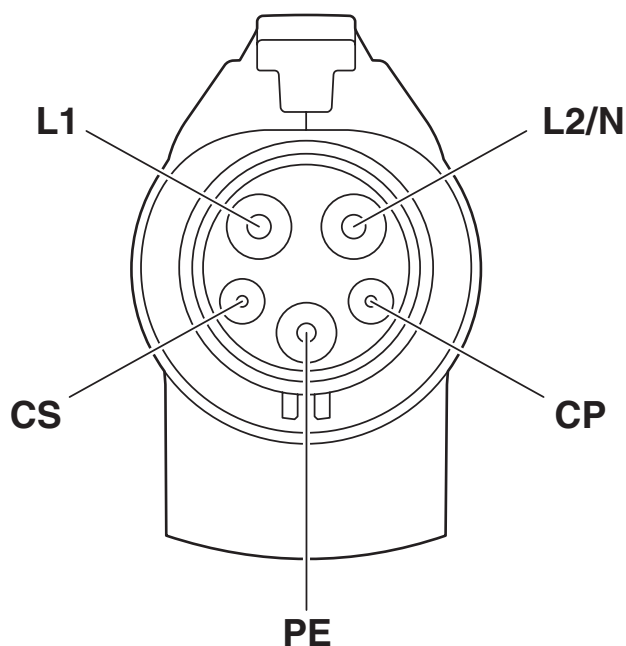

Connection diagram



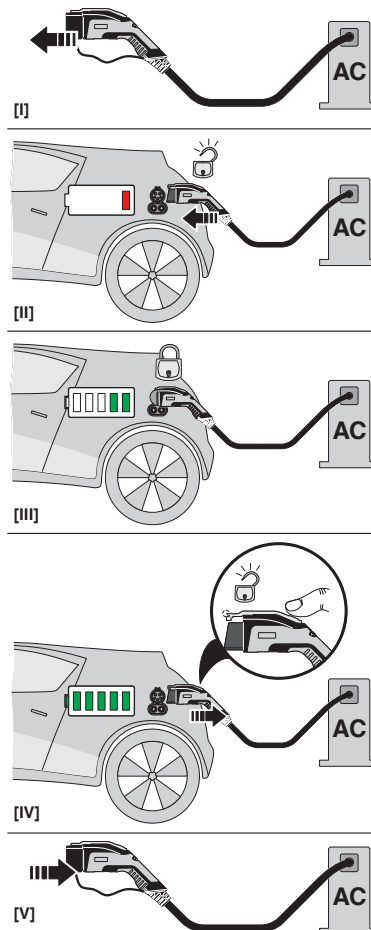
Pin assignment of the Vehicle Connector

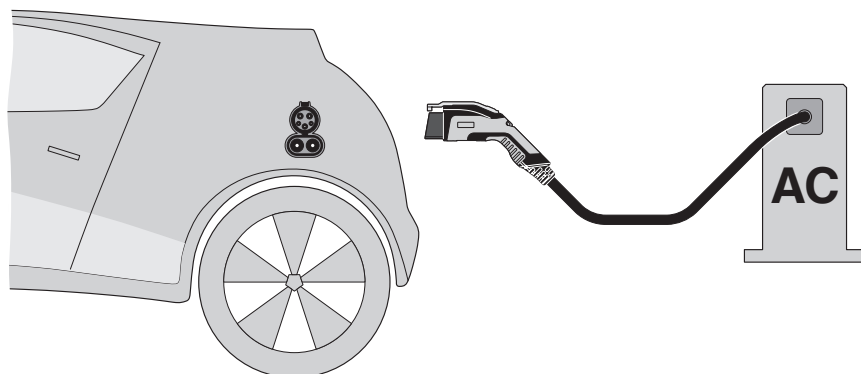

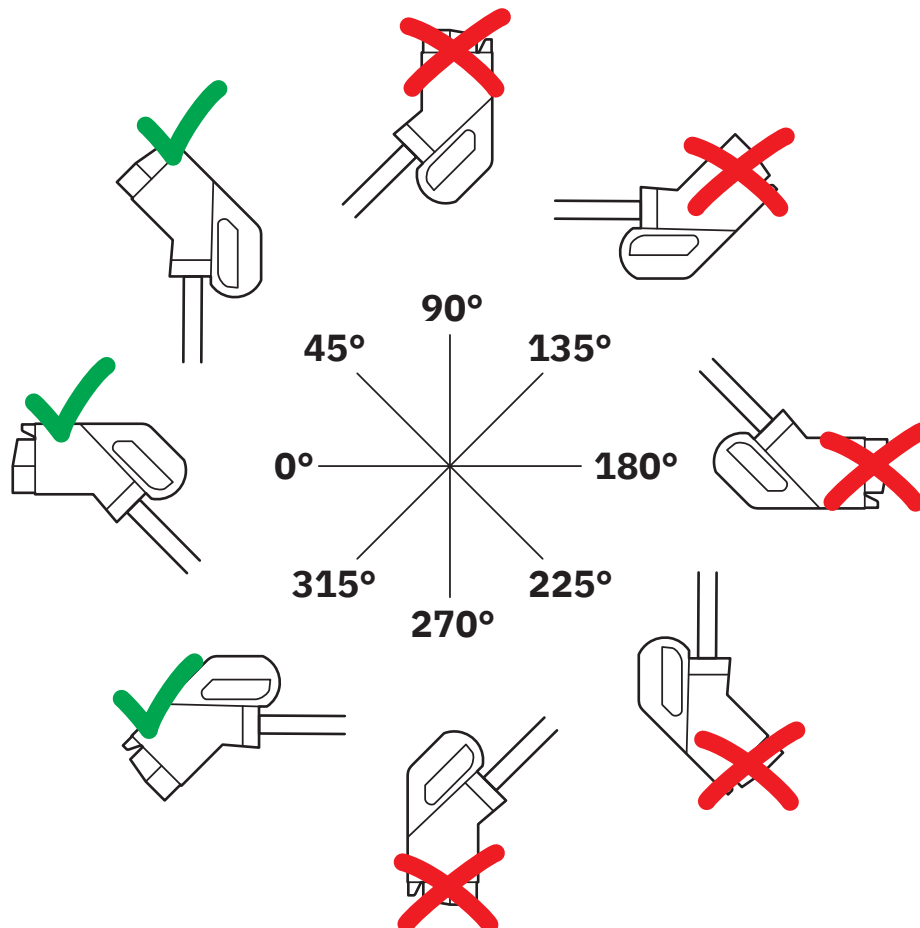
