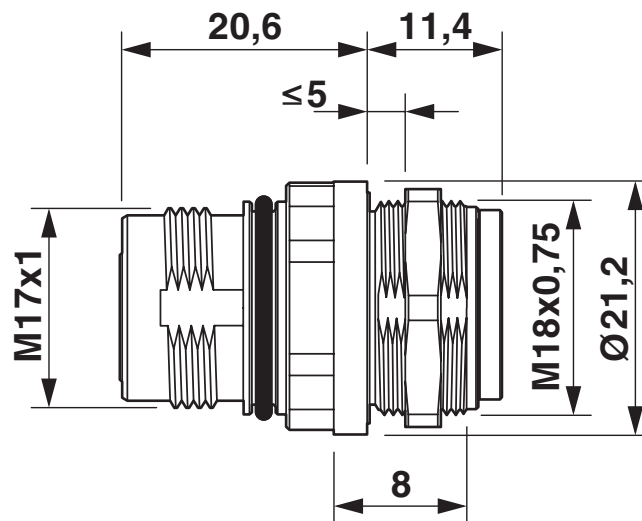

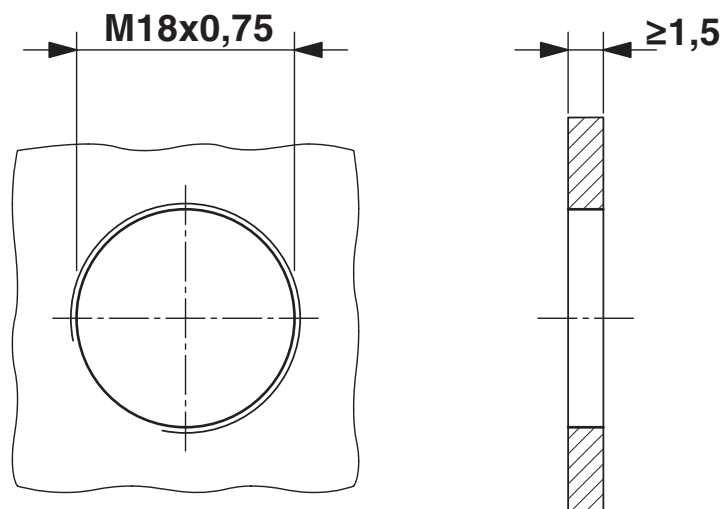

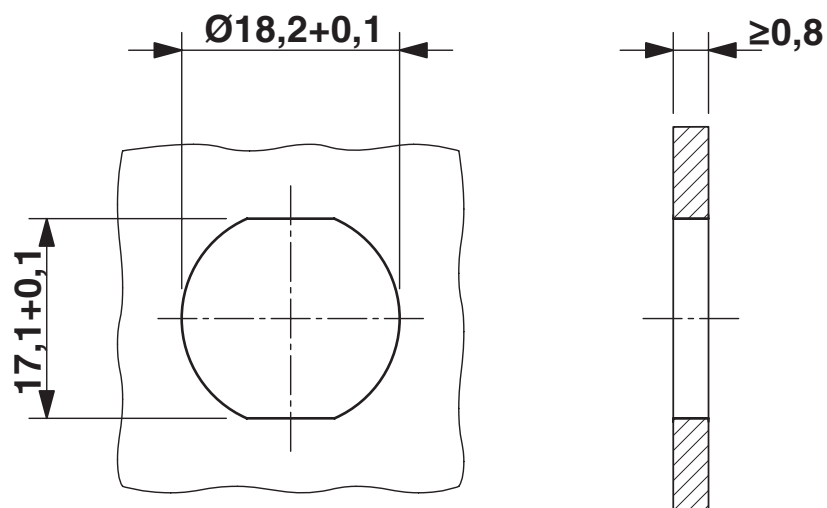

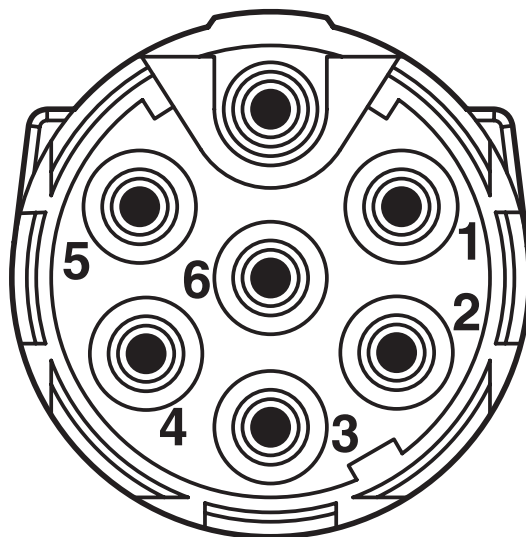
Installation dimensions: mounting with thread

Installation dimensions: mounting with anti-rotation protection and locking nut

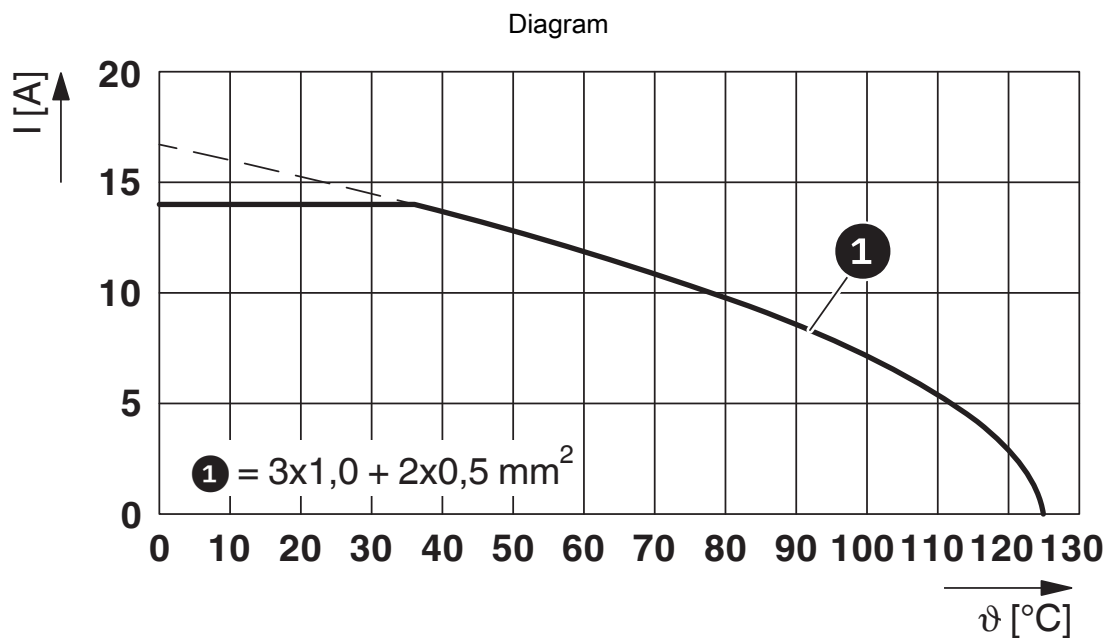
Schematic diagram
