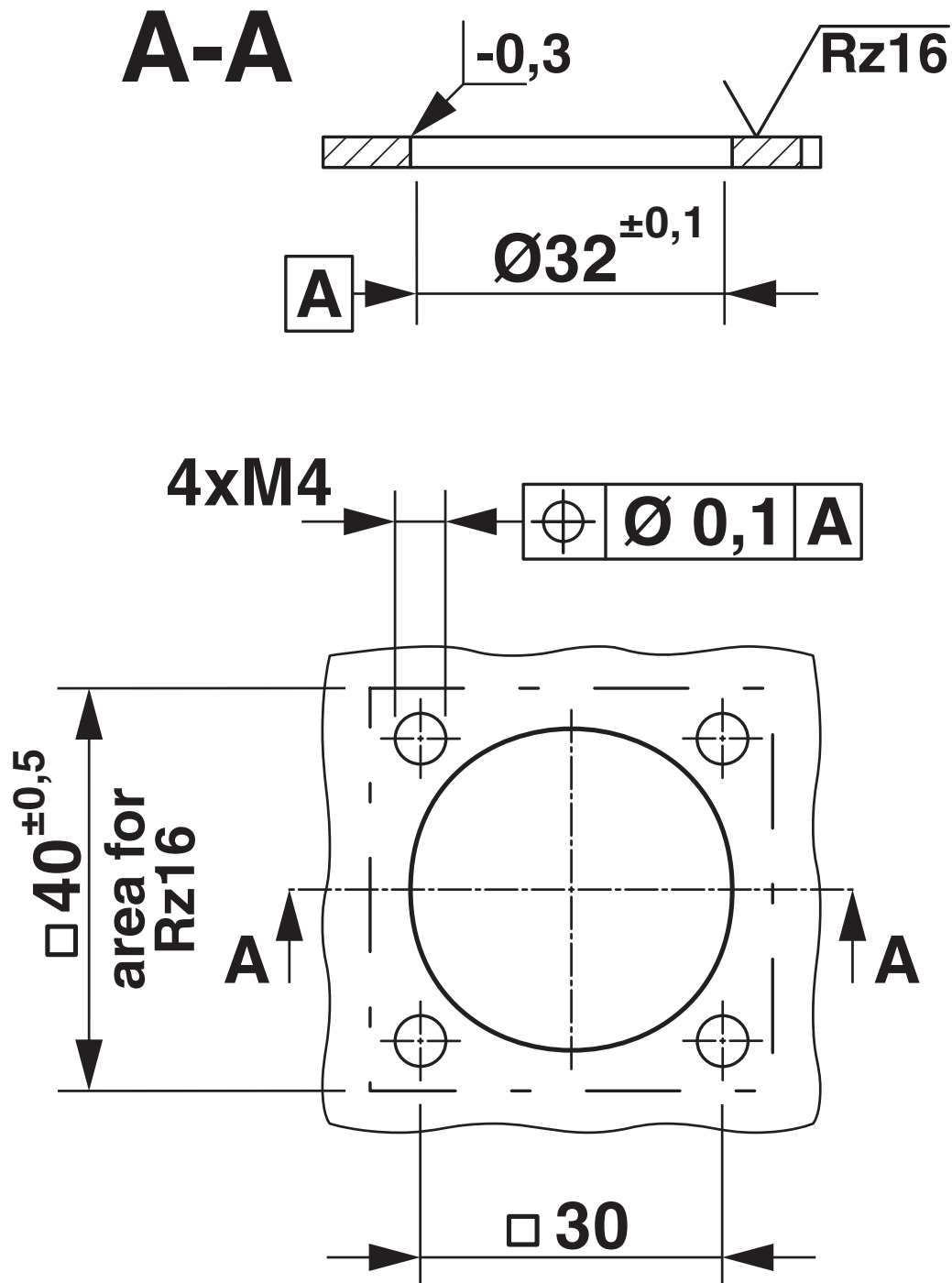

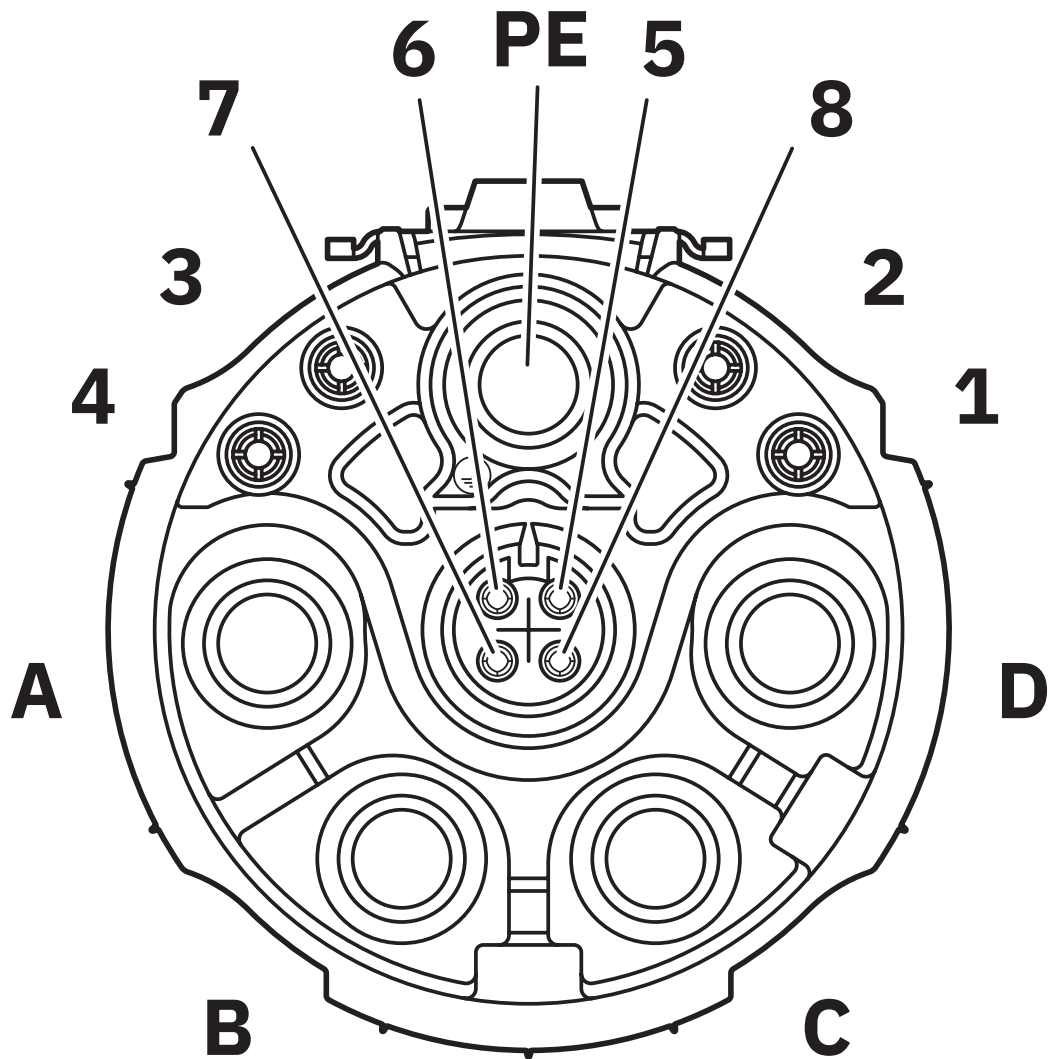

Schematic diagram



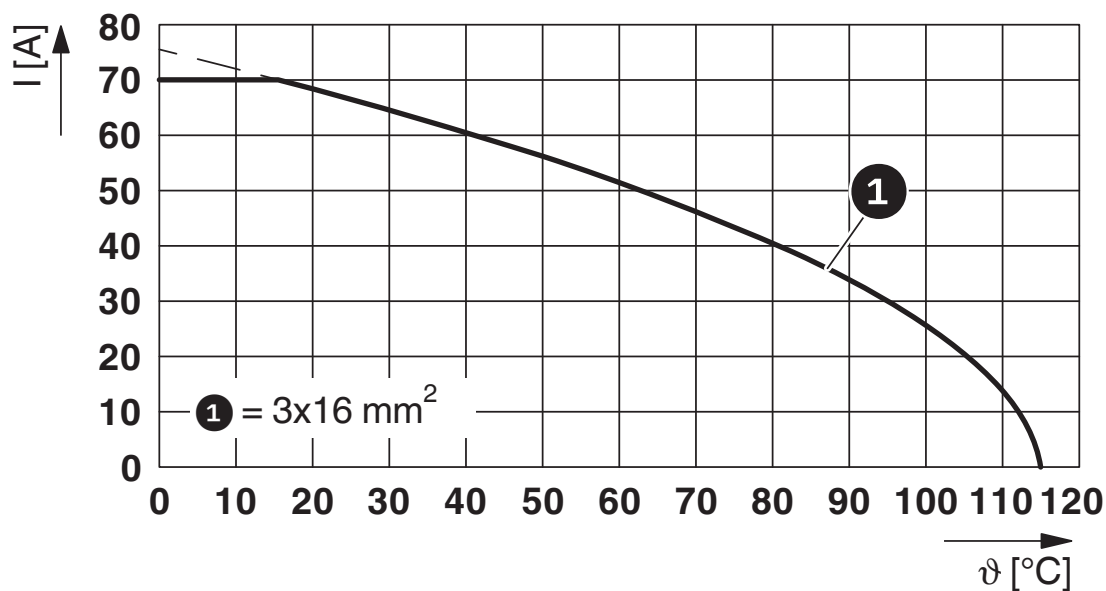
Pin assignment of socket signal, coding 1

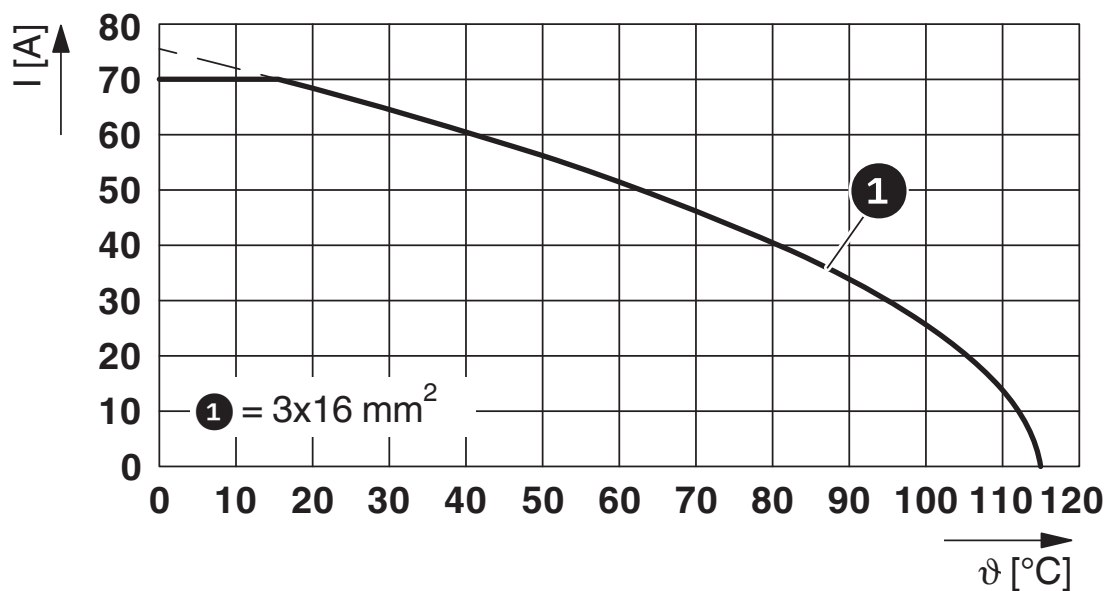

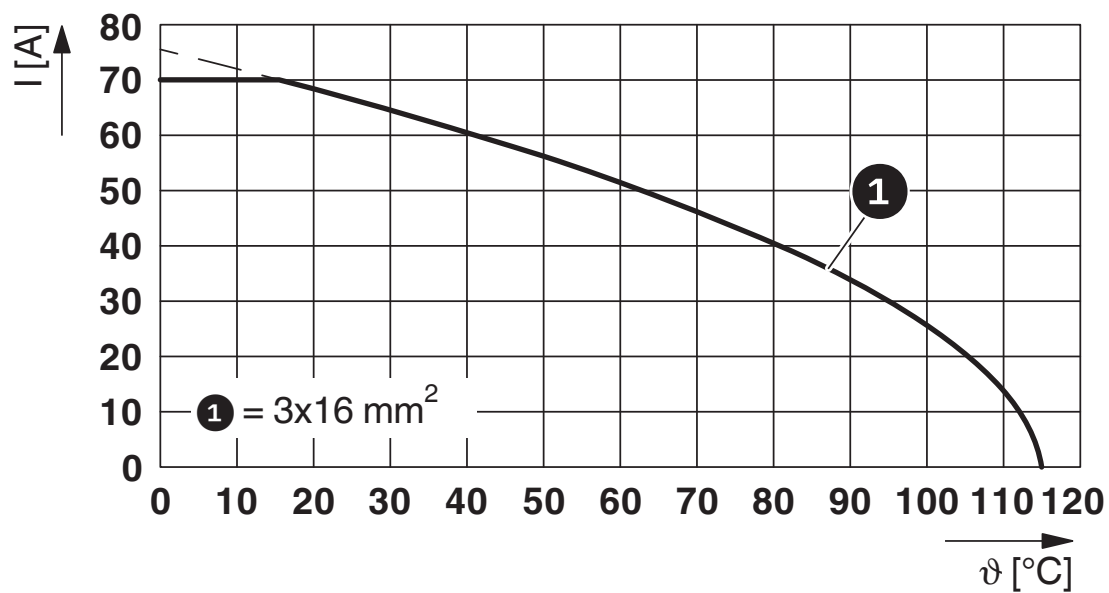
