

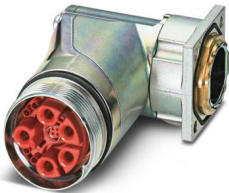

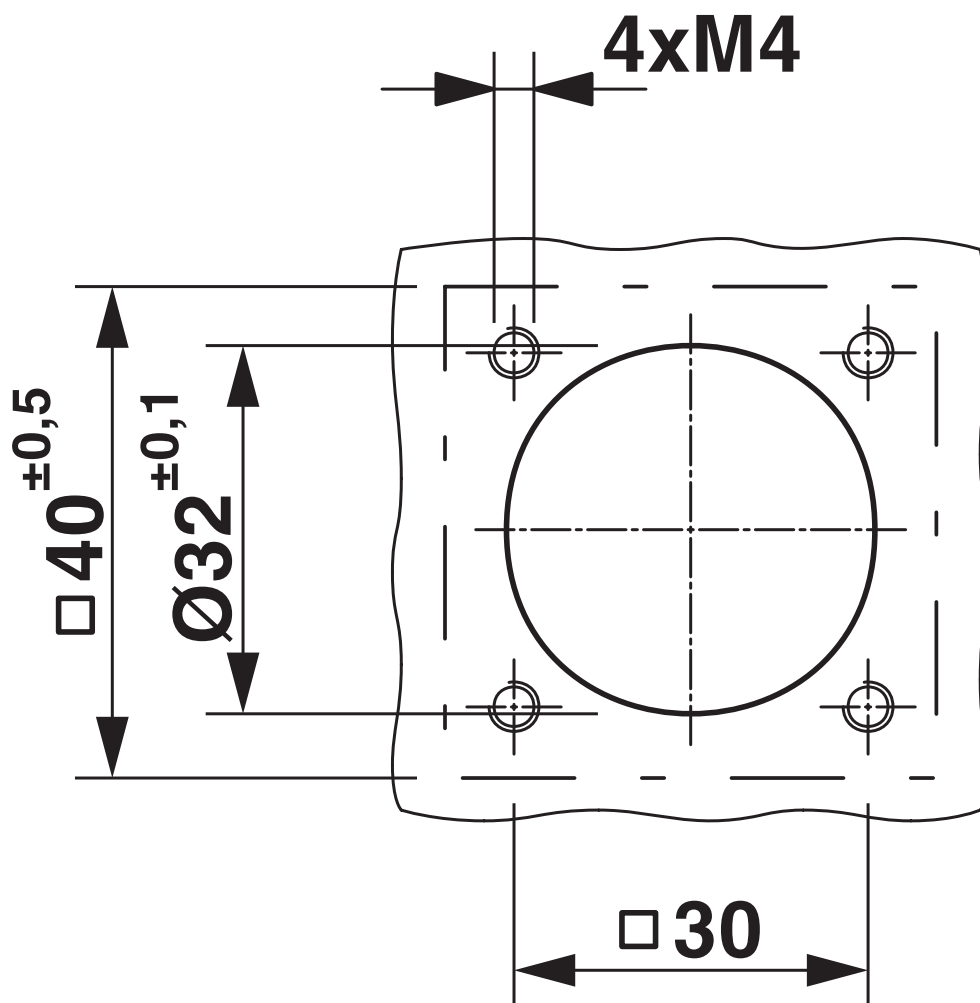

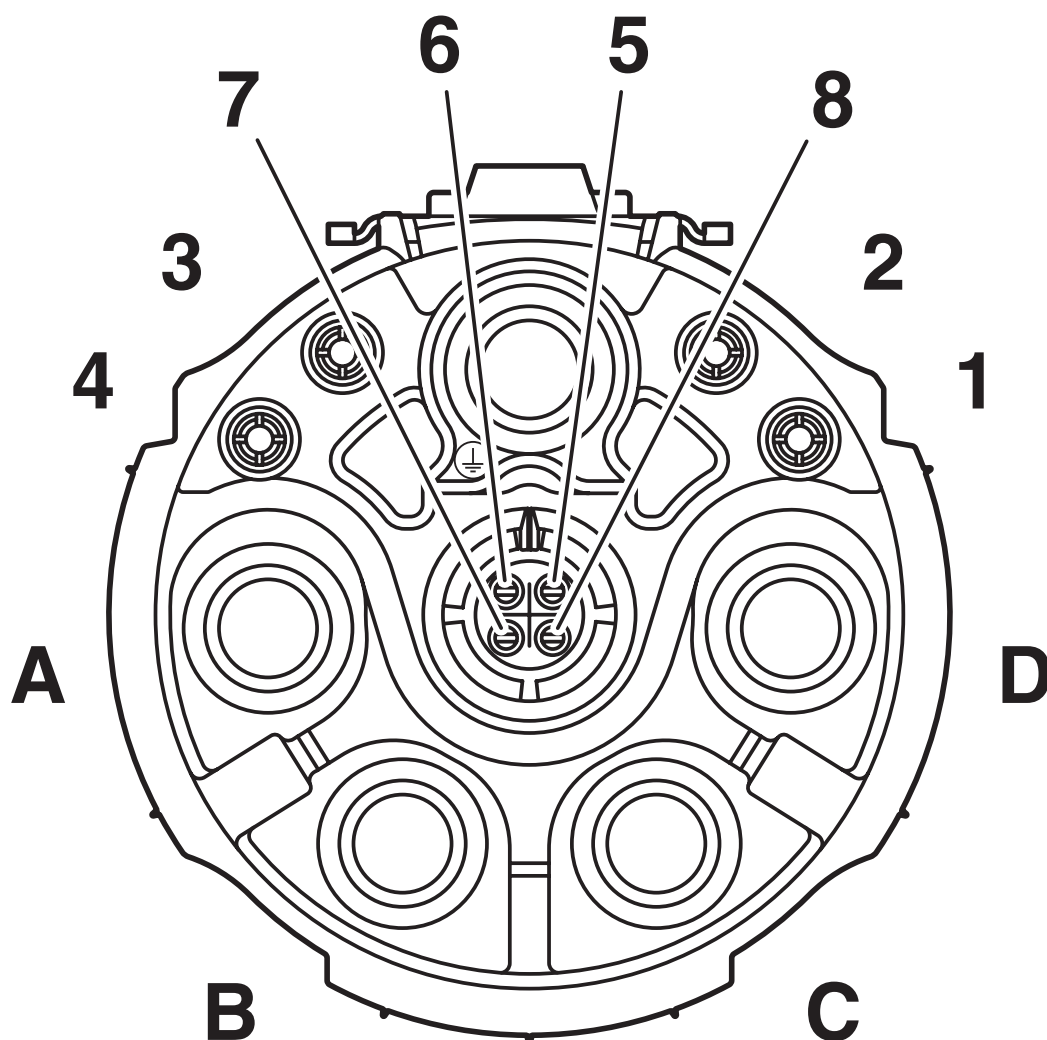

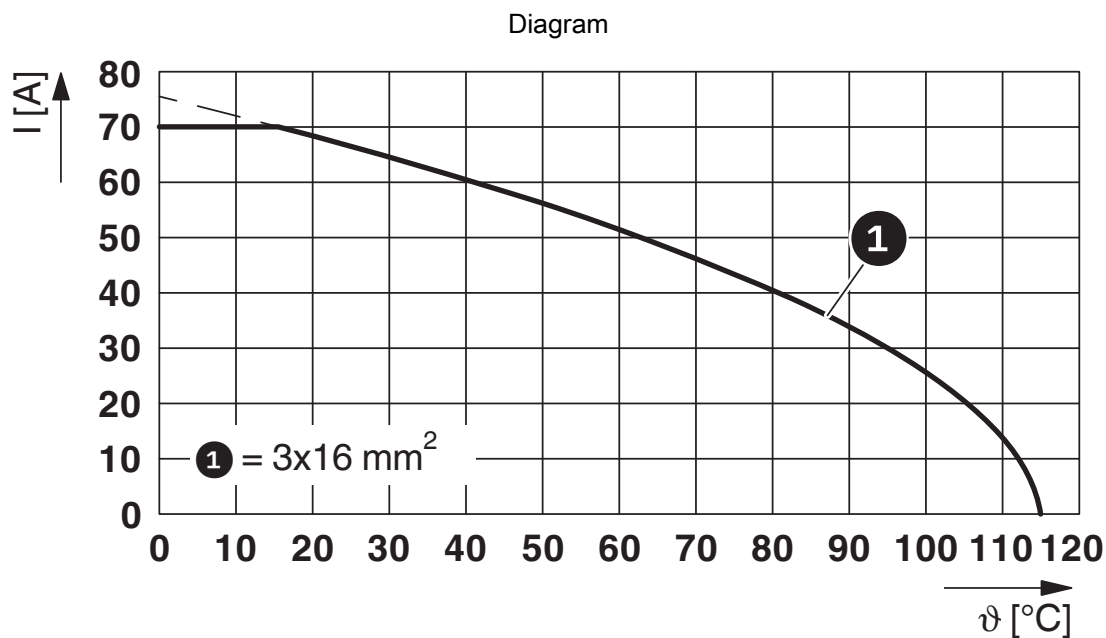

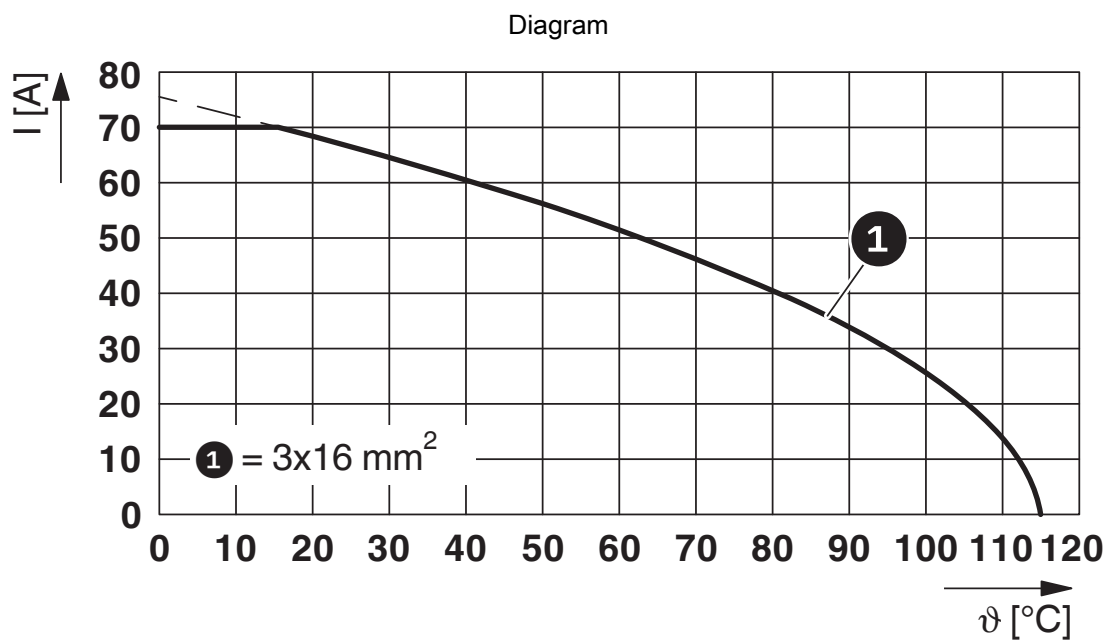
Schematic diagram
