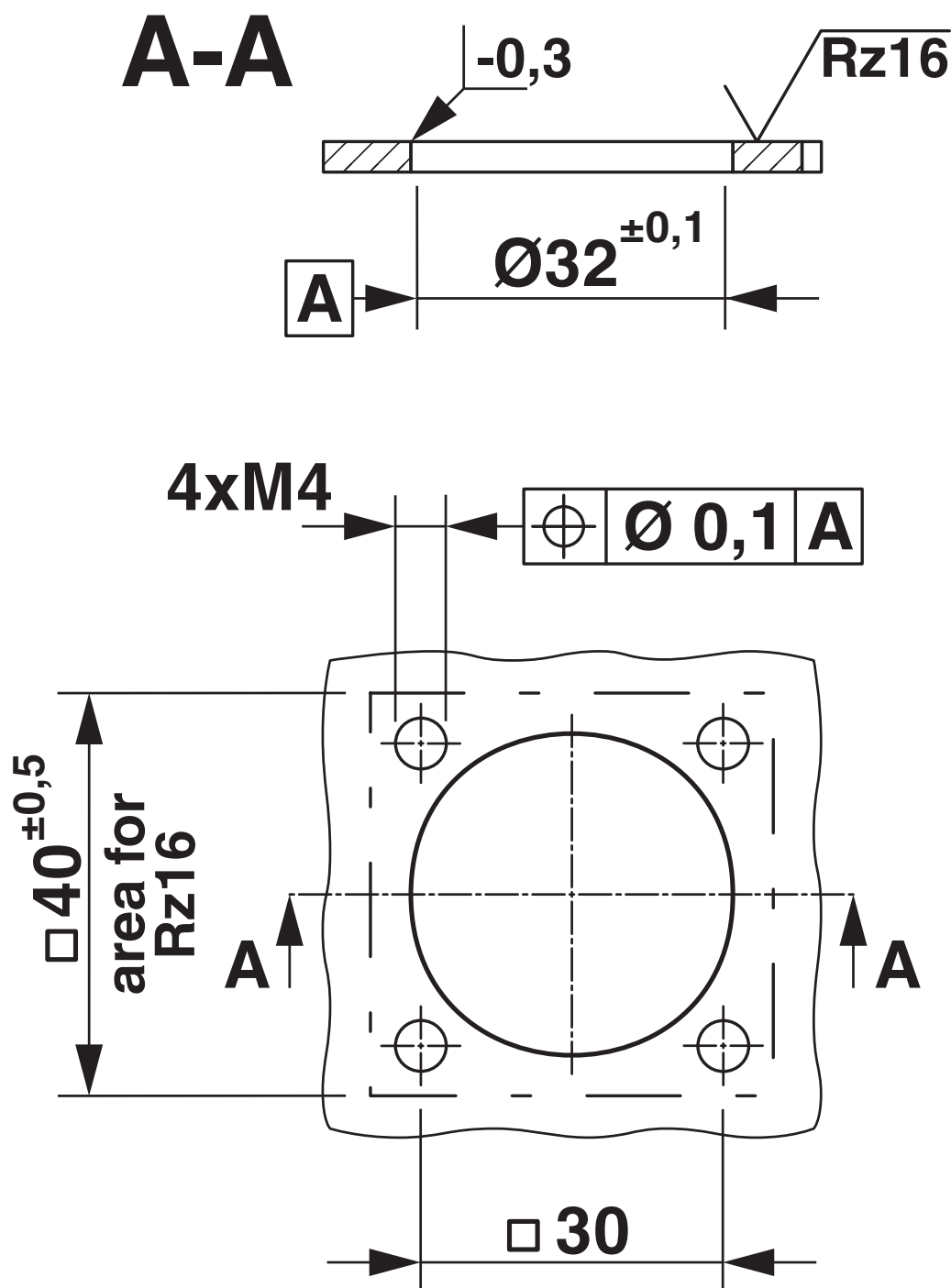

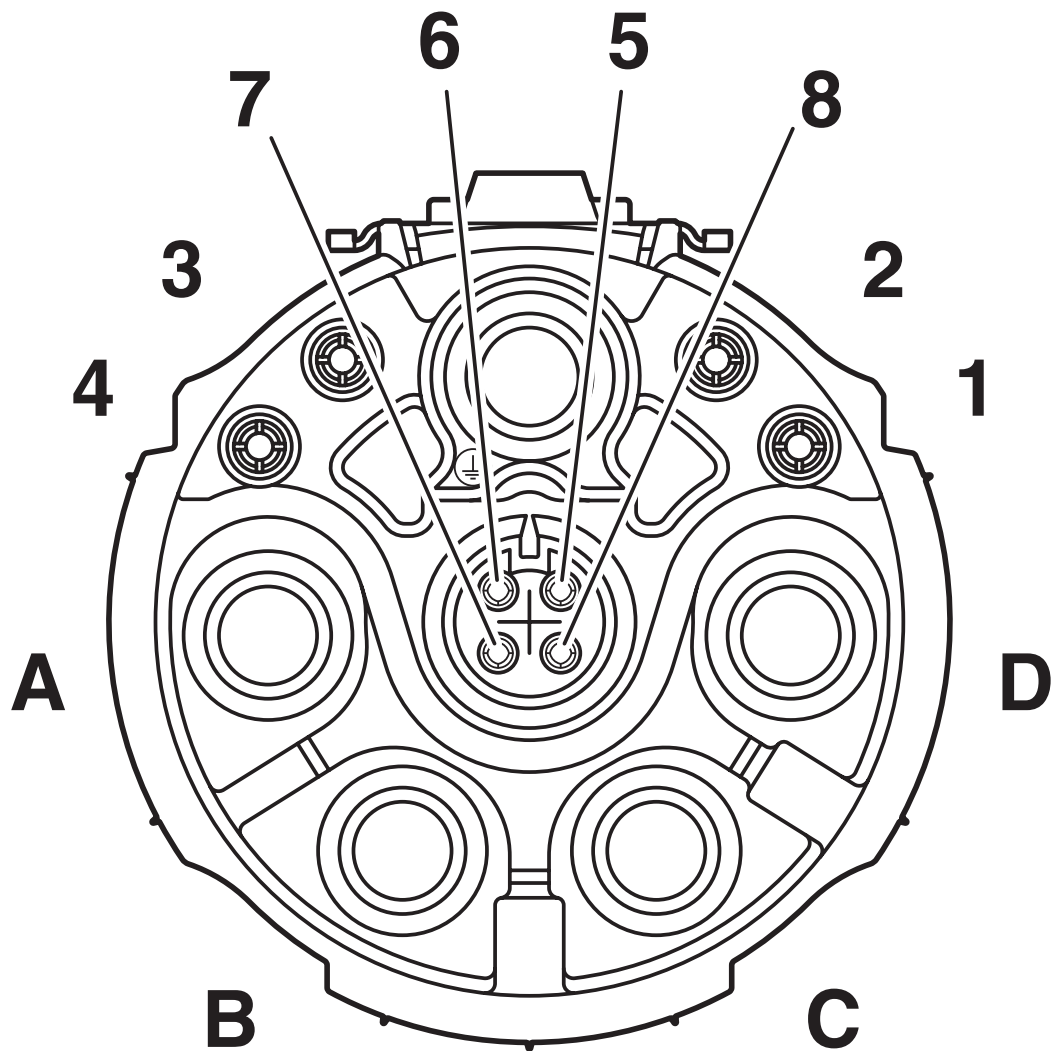

Schematic diagram



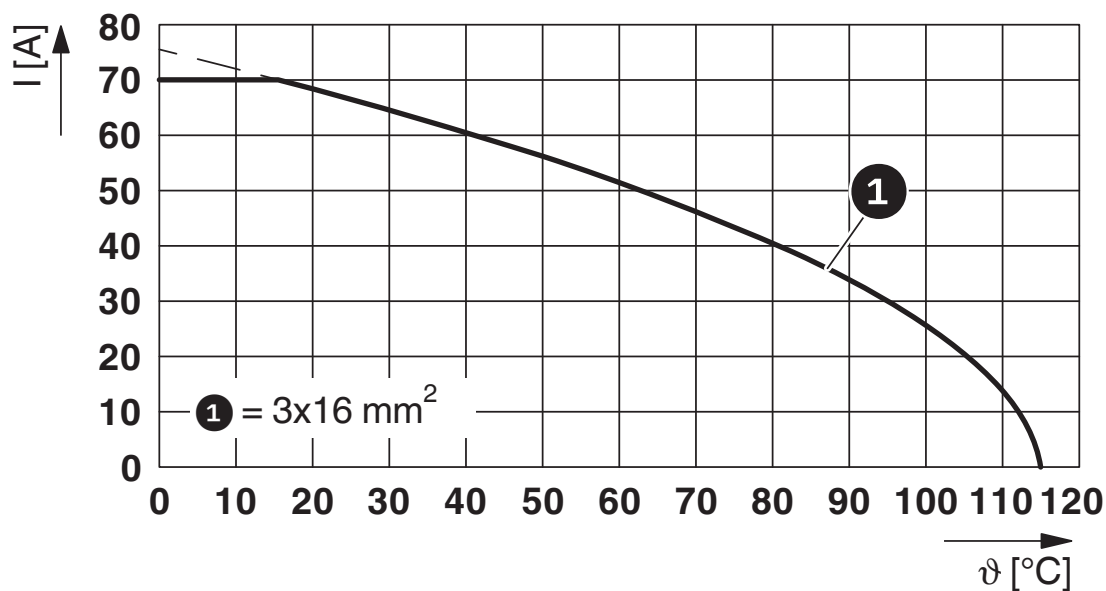
Pin assignment of socket signal, DC coding

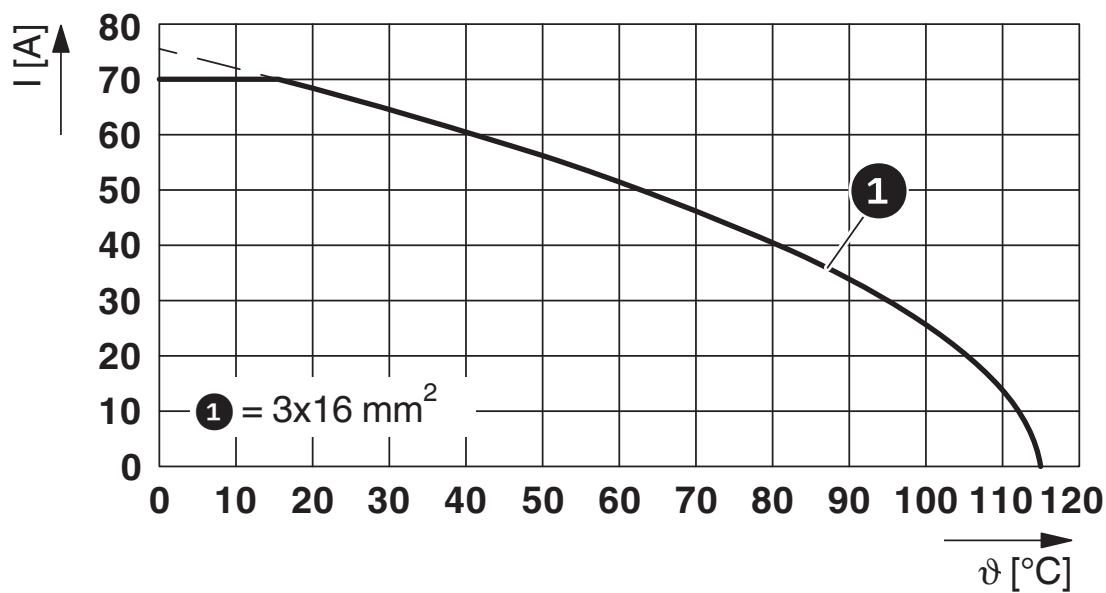

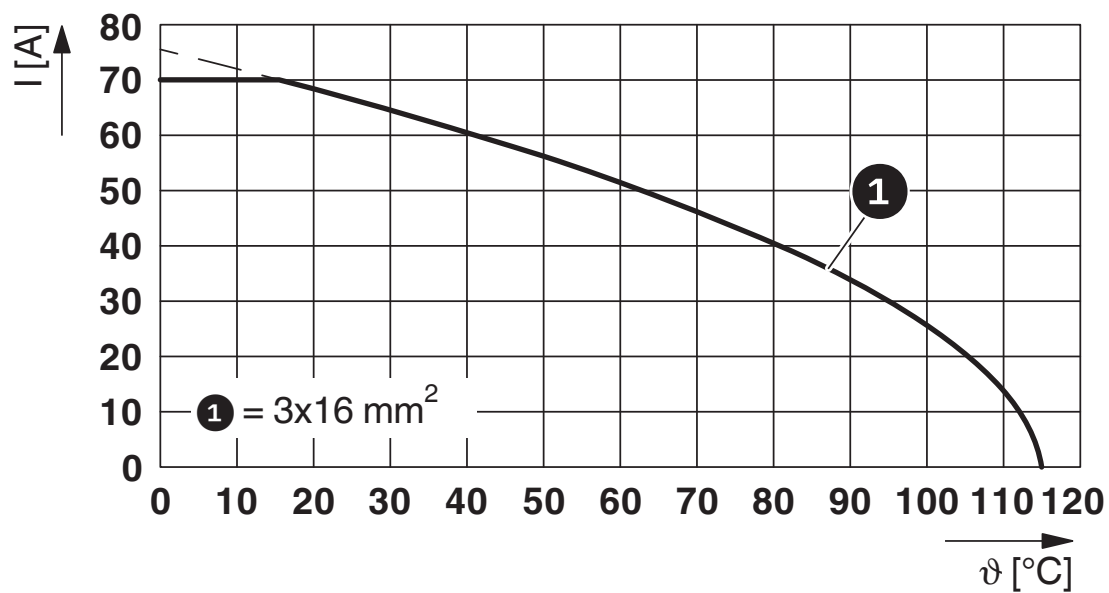
