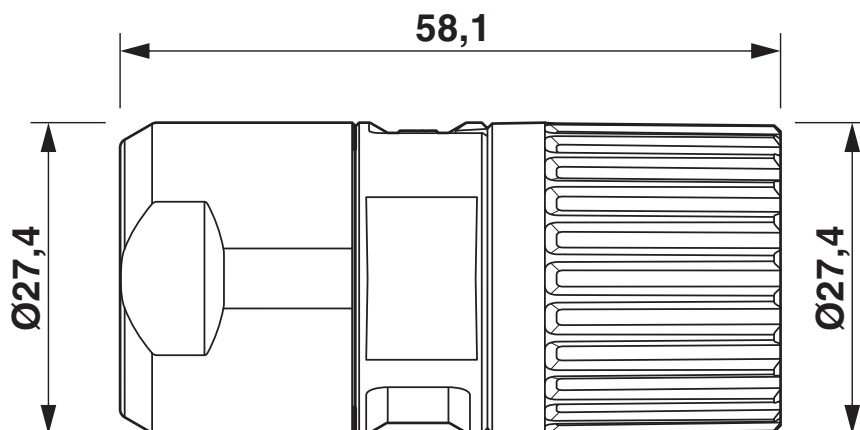

Dimensional drawing



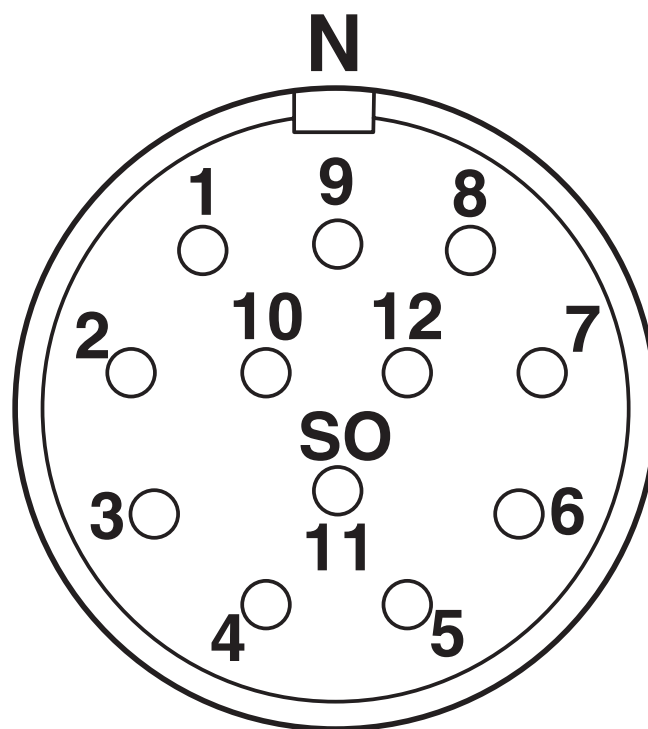
Dimensional drawing, housing

Schematic diagram

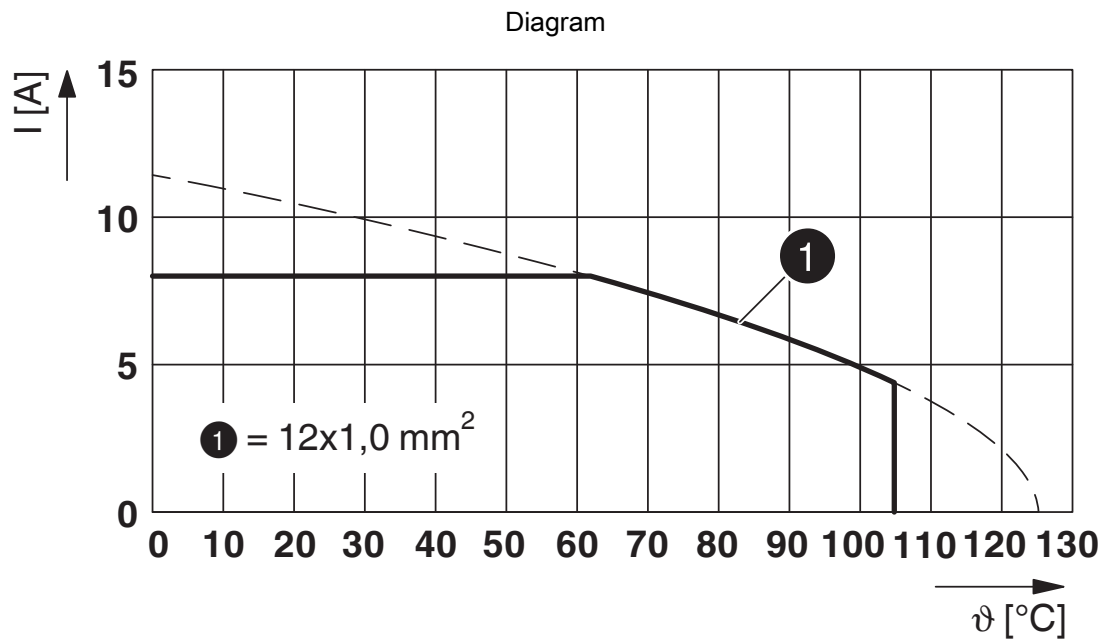


Connector pin assignment
